In that the above named defendant did, on or about the above mentioned date, time and location, did with the intent to harass, annoy or alarm another, the defendant did strike, shoves, kicks or otherwise subject the other person to physical contact.

To Wit: The defendant did punch and kick the victim several times, resulting in physical injuries. The victim received strikes to her face, body and rear of her head. The defendant also kneeled on the victim's chest pinning her to the ground.

Upon contact with the victim, your affiant did observe swelling on the victim's left and right side of her face. The victim related the defendant slapped her several times on both sides of her face. I did observe a black and blue mark below and adjacent to the victim's right eye. I observed on the victim's right jaw scrapes and a round abrasion. The victim related the round abrasion is a cigarette burn from the defendant. The victim related the defendant was also bending her wrist back. The victim related her both wrists are "sore and numb". The victim related the rear of her head is "sore". The victim related the defendant "banged her head against the ground a couple of times". The victim related the defendant kneeled on her chest to keep her from running away. The victim related it "hurts when I exhale".

**AFFIDAVIT OF PROBABLE CAUSE**

1. On 06/18/06 at approximately 1312 hours, your affiant was dispatched to 3098 Lincoln Highway, Paradise Township, Lancaster County for a report of domestic.
2. Upon arrival to the scene, your affiant made contact with the victim, Sasha Anne ENGLISH, W/N/F-23, DOB 01/24/83, 3098 Lincoln Highway, No Phone. The victim was at a neighbor's residence 3096 Lincoln Highway. ENGLISH related she has dated and lived with the defendant approximately one (1) year.
3. The victim related she was involved a verbal domestic with the defendant that turned physical. The victim related she attempted several times to leave the location. The victim related she also was yelling out windows for help.
4. The victim related the defendant slapped her several times on both sides of her face. The victim related the defendant was also bending her wrist back. The victim related the defendant "banged her head against the ground a couple of times". The victim related the defendant knelled on her chest to keep her from running away.
5. The victim related she broke free and ran down the steps out the front door and onto RT 30. The victim related the defendant did not follow her out the door. The victim related a neighbor her heard screaming and advised her to come into the residence. The victim related at that time 911 was called.
6. After interviewing the victim, she was transported to Lancaster General Hospital for observation of injuries sustained in the altercation.
