11. The facts of the most recent incident of abuse are as follows:

On about **Sunday, June 18, 2006** at approximately **12:00PM**  
**Kenneth Hoffman beat me up Saturday night and into Sunday morning around 11:30-12:00 pm, the police were called and a complaint was filed. I was taken into LGH by ambulance around 2 or 3 pm Sunday. He bend both my wrists almost breaking them, he put a cigarette out on my face and punched me in the eye on Sat. night. He picked me up on Sunday and threw me around the room into the frigg. and the dresser. He screamed obscenities at me. He slammed me into the floor causing me to black out and sufficated me with the mattress. Stopped me from breathing 3x and pinned me on thr ground. He threatened my life if I speak a word and said he will kill me.**

12. Prior incidents of abuse that Defendant has committed against Plaintiff or the minor child/ren, (including any threats, injuries, or incidents of stalking) are as follows:

**He has slapped me in the face many times prior poked me in my eyes, threw me down halls. he punched me over and over, grabbed me by the hair 2 wks prio. the police were called no charges filed. he has staved me, thrown me down steps, mentally abused me over and over for the last year very controllable.**

13. (a). Defendant **has not used**, or threatened to use firearms or other weapons against Plaintiff or the minor child/ren:

(b). To the best of my knowledge or belief, Defendant **does own** or possess firearms, other weapons, ammunition or a firearm license.

17. **FOR THE REASONS SET FORTH ABOVE, I REQUEST THAT THE COURT ENTER A TEMPORARY ORDER, and AFTER HEARING, A FINAL ORDER THAT WOULD DO THE FOLLOWING:**

a. Restrain Defendant from abusing, threatening, harassing, or stalking Plaintiff



and/or minor child/ren in any place where Plaintiff may be found.

- b. Evict/exclude Defendant from Plaintiff's residence and prohibit Defendant from attempting to enter any temporary or permanent residence of Plaintiff.
- c. Prohibit Defendant from having any contact with Plaintiff and/or minor child/ren, either in person, by telephone, or in writing, personally or through third persons, including but not limited to any contact at Plaintiff's school, business, or place of employment, except as the court may find necessary with respect to partial custody and/or visitation with the minor child/ren.
- d. Order Defendant to temporarily relinquish any firearm, other weapon, ammunition and any firearm license to the sheriff of this county and prohibit Defendant from transferring, acquiring, or possessing any firearm, other weapon, ammunition or any firearm license for the duration of the order.
- e. Order Defendant to pay the costs of this action, including filing and service fees.
- f. Order the police, sheriff or other law enforcement agency to serve Defendant with a copy of this petition, any order issued, and the order for hearing. Plaintiff will inform the designated authority of any addresses, other than the Defendant's residence, where Defendant can be served.
